Privileges: All privileges of Golf Stock Membership except the right to vote, hold elective and reciprocal golf privileges. Reduced cost of meeting room rentals in the Clubhouse. Dues include unlimited golf, unlimited driving range, club care and storage for one set of clubs, and taxes on dues. Food Minimum Charge: \$30 per month.

UNITED STATES MILITARY MEMBERSHIP

Family Monthly Dues: \$334.06 **Single Dues:** \$270.61

Active Duty Personnel assigned to military bases in Kitsap County. Privileges: All privileges of Golf Stock Certificate members except the right to vote, hold office and reciprocal golf privileges. Dues include unlimited golf, unlimited driving range, club care and storage for one set of clubs, and taxes on dues. Food Minimum Charge: \$30 per month.

Persons nineteen (19) through forty (40) years of age that are Active Duty Personnel assigned to military bases in Kitsap County. Privileges: All privileges of Golf Stock Certificate members except the right to vote, hold office and reciprocal golf privileges. * Family – Both adults must be under the age of 41. On your 41st birthday you are required to upgrade to Military Membership. Dues include unlimited golf, unlimited driving range, club care and storage for one set of clubs, and taxes on dues. Food Minimum Charge: \$30 per month.

JUNIOR EXECUTIVE MEMBERSHIP

Initiation: \$500

***Family Monthly Dues:** \$197.35 **Single:** \$160.20

Persons nineteen (19) through forty (40) years of age. Privileges: All privileges of Golf Stock Certificate members except the right to vote, hold office and reciprocal golf privileges. * Family – Both adults must be under the age of 41. On your 41st birthday you are required to upgrade to Golf Stock Membership. Dues include unlimited golf, unlimited driving range, club care and storage for one set of clubs, and taxes on dues. Food Minimum Charge: \$30 per month.

SOCIAL MEMBERSHIP

Initiation: \$300

Family Monthly Dues: \$60.34

Privileges: Use of the pool, clubhouse, including lounge, coffee shop, dining and club grounds. Four (4) rounds of golf per year with payment of current greens fees. Food Minimum Charge: \$30 per month.

JUNIOR MEMBERSHIP

Single Monthly Dues: \$90.78

For persons less than 19 years of age. No Food Minimum required.
